MESSAGE FROM THE REGISTRAR— Year in Review

As 2023 comes to a close, I find myself reflecting on this past year and I am pleased to see the many advancements that have been made in the pharmacy profession in the public's best interest.

In April, the provincial government announced changes to the Authorization to Prescribe Regulations to enhance pharmacists' prescriptive authority. The ability to further extend prescriptions, the addition of new approved ailments or conditions, and the addition of the ability to prescribe hormonal contraceptives all serve to increase accessibility to healthcare for patients in the province. More recently, changes to the Authorization to Administer Drug Therapy by Inhalation or Injection Regulations have enabled pharmacy technicians to become authorized to inject,



which in turn allows pharmacies to increase their capacity to provide these services to the public. For further details on the changes to scope of practice of registered pharmacy professionals in 2023, please refer to the article on page 3 of this issue. In 2024, NLPB will continue to work closely with the Department of Health and Community Services on revisions to provincial pharmacy legislation to further enable and support pharmacy professionals in using the full extent of their expertise to meet the health needs of their patients.

Another important milestone this year was the launch of NLPB's Continuous Quality Improvement and Medication Incident Reporting Program, MedSTEP NL. The Quality Assurance team and MedSTEP NL Task Force have been working hard all year to develop the program and accompanying Standards of Practice. The first implementation deadline is the end of this year, at which time the pharmacist-in-charge (PIC) and pharmacy staff should have completed a review of the standards and all available resources, and started work on the development of a policy and procedure manual for MedSTEP NL. NLPB will continue to develop resources to support PICs and pharmacy staff in implementing the standards, with the goal to begin reporting aggregate data on medication incidents and near-misses in the province by 2025. Also this year, the NLPB board and staff developed and published our 2023-2026 Strategic Plan. The strategic goals focus on supporting pharmacy professionals, improving access to health care, and strengthening trust in the regulatory process. Each goal was developed following a comprehensive risk analysis with consideration also given to the feedback we received during the consultation process and a review of the current regulatory environment on national and provincial levels. As we move into the new year, the staff and I will work to operationalize the plan, providing progress updates along the way. Finally, I would like to acknowledge the tremendous work of pharmacy professionals in Newfoundland and Labrador this past year. Pharmacies have become an important touchpoint for patients throughout the province, to address their healthcare needs. However, with the increase of services available, there is also an increased demand on pharmacy professionals' time and expertise. As such, NLPB's 2023-2026 Strategic Plan aims to explore NLPB's role in pharmacy professionals' wellness and pharmacy staffing as we recognize these as important enablers to quality and safe care. Please take whatever time you can this holiday season to focus on your own wellness. On behalf of NLPB board and staff I would like to wish you a happy and restful holiday season. We look forward to working with you in the New Year!

PRACTICE UPDATES — Improving Integration of Pharmacy Professionals in 2023

NLPB has been working closely with the Department of Health and Community Services to expand the role of pharmacy professionals in the provincial healthcare system to ensure the public's needs are being addressed and that all persons have access to quality healthcare. NLPB is pleased to see much of this work come to fruition in 2023 in the form of legislative and regulatory change. Some of these changes include:

Authorization to Prescribe Regulations and Standards of Practice:

- Ability for pharmacists to extend prescriptions for up to a year.
- Removal of the limitations on quantity of medication given during an extension to "the amount previously filled" and removal of the limitation related to an extension not being permitted if the prescription had previously been extended.
- Additions to list of approved ailments/ conditions:
 - Conjunctivitius
 - Fungal Nail Infections
 - Herpes Zoster (Shingles)
 - Urinary Tract Infections
- Ability for pharmacists to prescribe hormonal contraceptives with some limitations.
- Ability for pharmacists to prescribe post-

exposure prophylaxis with referral from a regional medical officer of health or their designate.

Authorization to Administer Drug Therapy by Inhalation or Injection Regulations and Standards of Practice:

- Ability for pharmacy technicians to apply for authorization to administer injections.
- Reduction of age limit for the administration of vaccines for COVID-19 and influenza from 5 years to 2 years of age.*

*Please note, this age limit reduction applies only to the administration of the COVID-19 and influenza vaccines and does not apply to other vaccinations (i.e. travel).

Standards of Practice - Medical Assistance in Dying:

Ability for pharmacy technicians collaborating with a pharmacist in a hospital setting to release medications for MAID to the prescribing physician or nurse practitioner.

COMING SOON: PHARMACY TECHNICIAN INJECTION TRAINING WITH MUN

The School of Pharmacy at Memorial University is launching an injection-training course for pharmacy technicians. The program is currently undergoing accreditation by CCCEP, with an anticipated start date in January 2024. As a two-stage program, participants will complete online training modules independently through Memorial University's online learning program, Brightspace, before attending the in-person training session.

This program is currently only available for pharmacy technicians who are currently registered or are eligible for registration with a provincial regulatory body. Registration for the online self-directed modules will be separate from registration for the live training sessions for this program. Individuals may only register for the live training session after successful completion of the online self-directed modules. Participants will not be permitted to register for the in-person training session if they have completed their online training program through another provider. Registration will open in January 2024, with the first live session scheduled for Thursday, February 22, 2024 in St. John's, NL. More details regarding pricing and registration will be shared in the new year.

BOARD MEETING UPDATE

Since the last issue of The Apothecary, the NLPB Board of Directors has held two meetings, on October 5 and December 8, as well as the Annual General Meeting, which was held following the meeting of the board on October 5.

Budget 2024

The 2024 budget was approved by the board on October 5, 2023 at the recommendation of the Finance and Audit Committee.

Committee Appointments

Executive Committee: A new executive committee was elected at a special board meeting held on October 5, 2023 following the Annual General Meeting. Henry White moved into the role of Chair of the Board, Jason Ryan was elected to the Vice Chair role, and Shawn Bugden and Mark Sheppard were elected to join the committee as executive members.

<u>Disciplinary Panel:</u> Lori Power was appointed by the board to the disciplinary panel for a 3-year term.

<u>Complaints Authorization Commitee:</u> Board members Terry Foss, Justin Peddle, Amy Randell, and Andrew Sweetapple were appointed to join the Complaints Authorization Committee alongside existing members Jason Ryan (CAC Chair) and Mark Sheppard.

New Interpretation Guide - Use of Social Media

As part of NLPB's ongoing work to revise the Code of Ethics and develop related interpretation guides, the NLPB Pharmacy Practice Policy - Registrant Use of Social Media has been converted to a n interpretation guide. Converting the policy to a Code of Ethics Interpretation Guide is intended to clarify the direct link between a registered pharmacy professional's conduct online and the code of ethics to which they must adhere.
